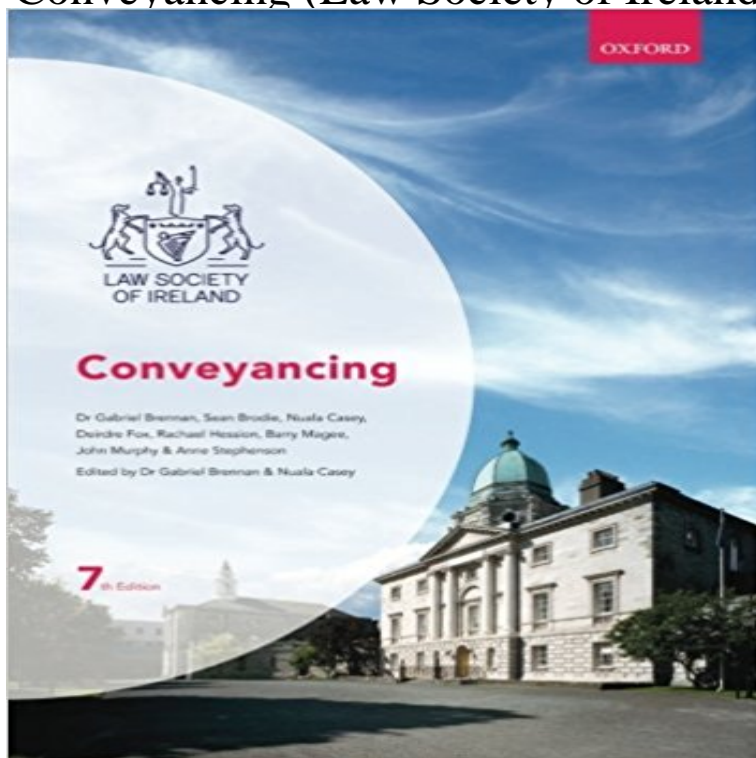


Conveyancing (Law Society of Ireland Manuals)
