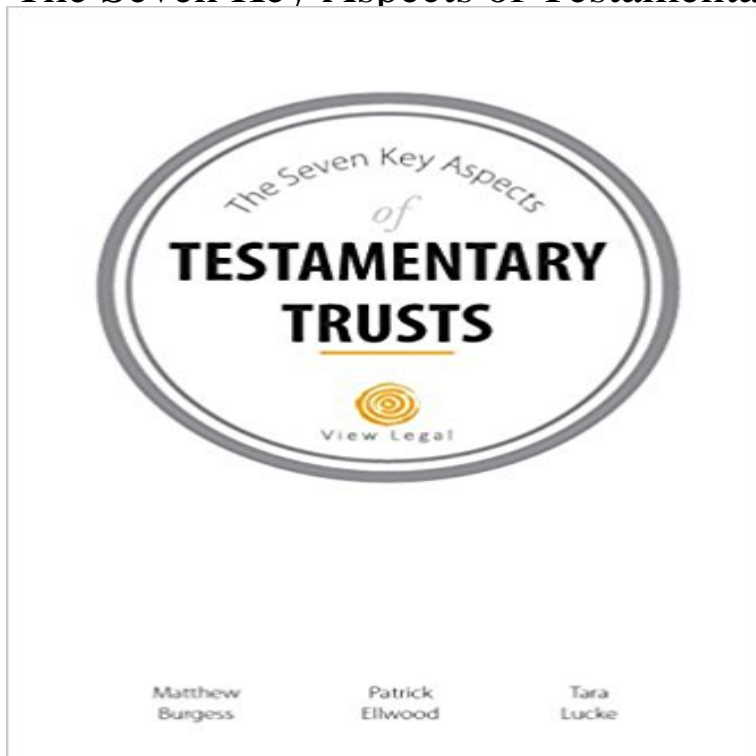


# The Seven Key Aspects of Testamentary Trusts
