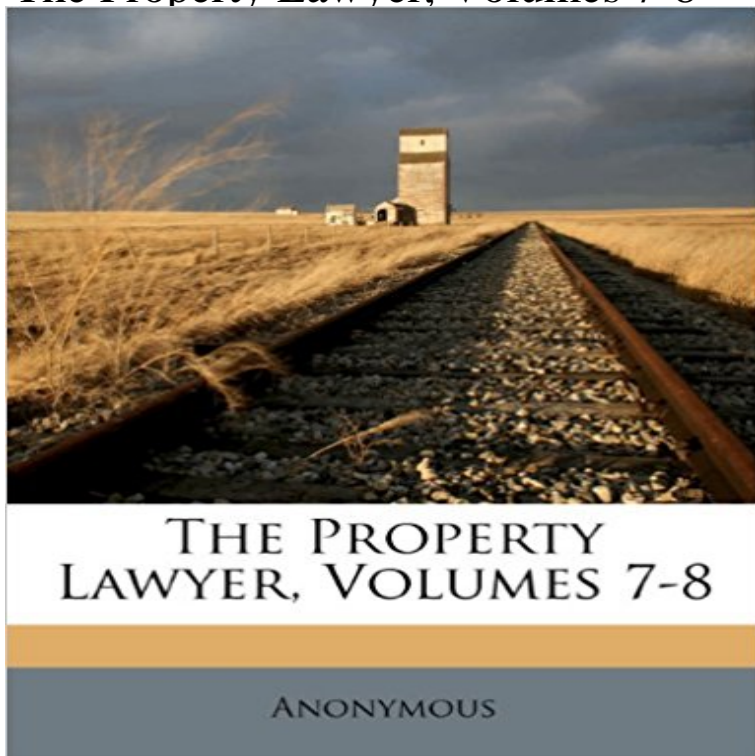


## The Property Lawyer, Volumes 7-8
