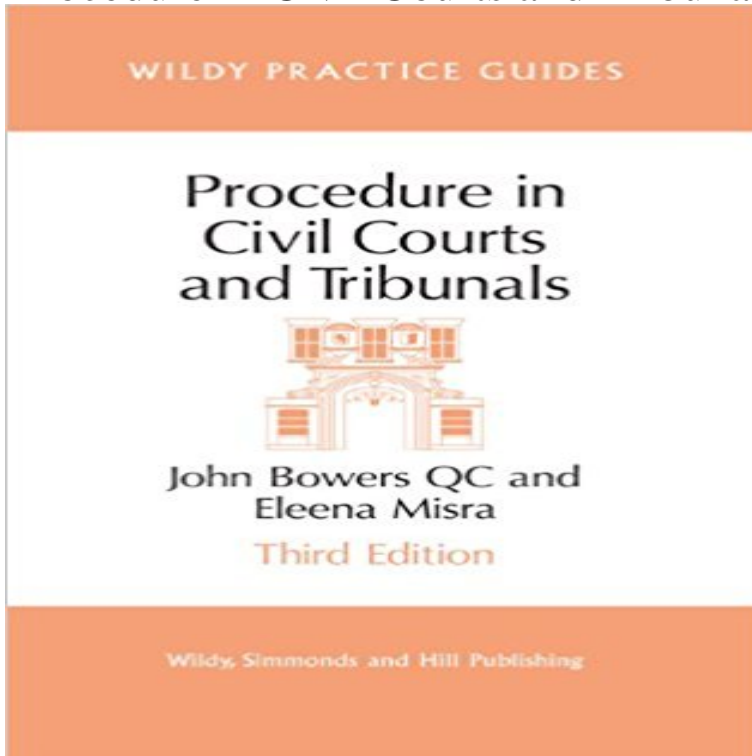


Procedure in Civil Courts and Tribunals (Wildy Practice Guide)
