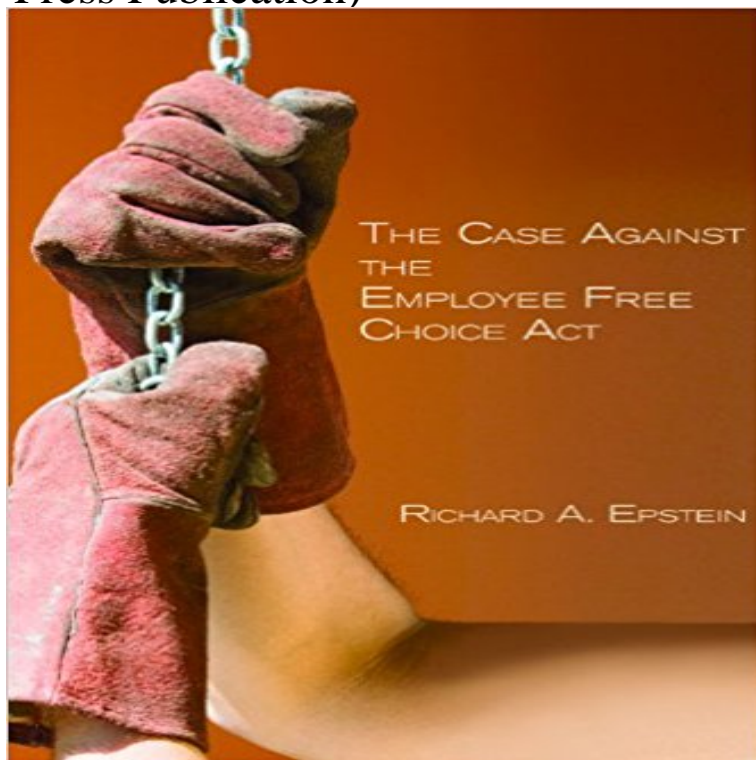


## The Case Against the Employee Free Choice Act (Hoover Institution Press Publication)
