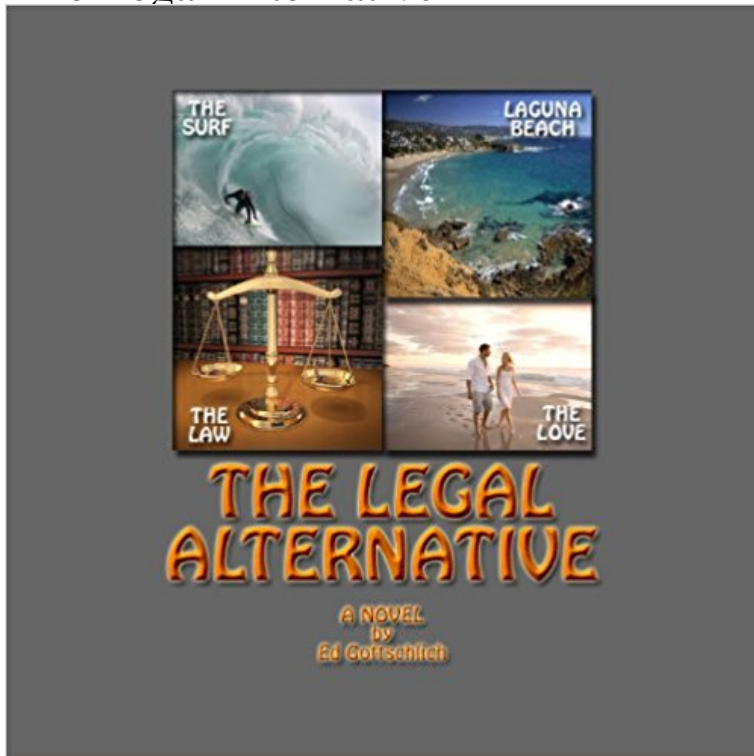


## The Legal Alternative
