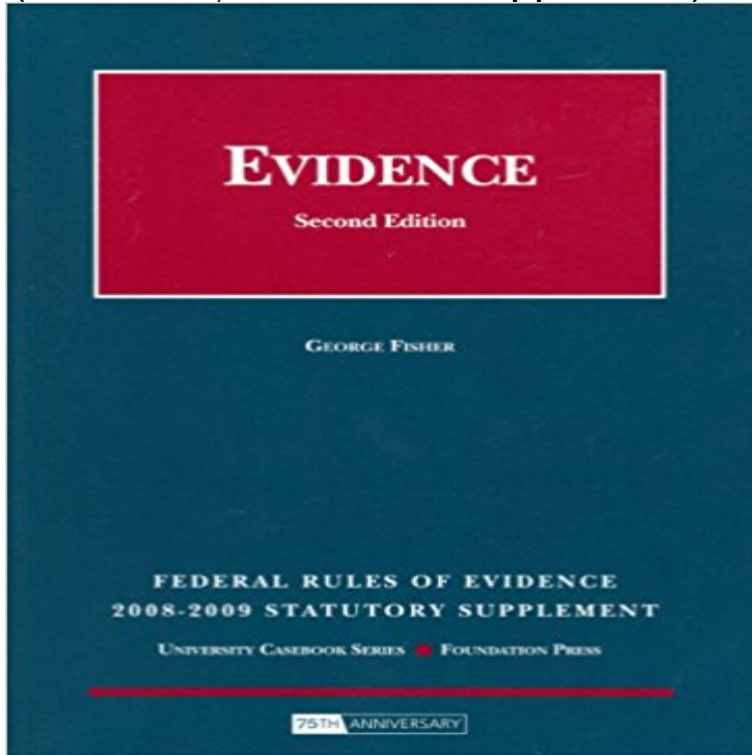


## Federal Rules of Evidence Statutory Supplement, 2008-2009 ed. (University Casebook: Supplement)
